

“On January 28, 2021, I visited the address Rodovia Augusto Montenegro S/N Km7, Parque Verde, Belem, Para, Brazil. It is an industrial plant situated at one of the main highways in the city. There are some commercial establishments around, including a supermarket in front of the company. There is a residential neighborhood beside that area. It was not possible to get inside the compound without an appointment or an authorization, but I spoke with the security guards: they confirmed the company XXXXX Companhia Xxxxxx de XXXXXXXX is well located at the given address and is currently operating”.
